- Copy of a valid California Department of Fish and Wildlife lake or streambed alteration agreement, pursuant to Fish and Game Code section 1602 or written verification from the Department of Fish and Wildlife that a lake and streambed alteration agreement is not required
- Compliance with Water Code section 13149
- Evidence of hazardous materials record search of the EnviroStor database for the proposed premises and protocols to protect employee health, if needed
- Evidence of conformance with the California Environmental Quality Act (CEQA)
- Power source information (for indoor and mixed-light cultivators only)
- Fines or penalties for cultivation or production on private or public land

**SECTION C - DECLARATIONS**

I attest that the fire department has been notified of the cultivation site.
